*For every student group, at least 70% of Kindergarten and 50% of 1st and 2nd grade students will score at target by  
For all student groups, at least 60% of Kindergarten and 75% of 1st and 2nd grade students will make at least one y  
For all student groups, no more than 25% of 3rd grade students with score Below Basic on the Reading PSSA.  
At least 60% of students will attend 95% or more of school days.  
100% of Kindergarten through 2nd grade students will have 0 out-of-school suspensions.*

**STUDENT RESPONSIBILITIES:**

Be responsible to maintain school computer equipment.*
